Morning Plenary: Turning Knowledge into Action

Susan Lett, MD, began her professional career in nursing before becoming a physician. MORNING WORKSHOPS:

A. Vaccine Preventable Diseases: Working Together to Control the Spread

B. The Massachusetts Immunization Information System (MIIS): What You Need to Know

Natalie Joseph, MD, MPH is an Assistant Professor in Pediatrics at Boston University School of Medicine and an Adolescent Medicine Specialist at Boston Medical Center. As a primary care clinician to adolescents, she encounters many patients with early onset of sexual activity and multiple partners, both of which increase their risk of pregnancy, sexually transmitted infection (STI), human papillomavirus (HPV) infection and cervical cancer. She has had an interest in serving the pregnant and parenting teens population and has had special clinic sessions at Children's Hospital's Young Parenting Program and BMC's Teens and Tots program. She has been director of the teens and tots clinic at Boston Medical Center since January 2001. She has also been involved in cervical cancer prevention research since 2007, when she first collaborated with an obstetric colleague exploring parental acceptability of the HPV vaccine among adolescent girls. She aims to become a leader in teen pregnancy and parenting programs, to reduce disparities in adolescent prenatal care, birth and child health outcomes, and injury prevention between low-income and minority pregnant and parenting teens. She also wants to focus on cancer prevention, specifically cervical cancer disparities in minority communities.

Ann Becker RN, DNP is the University of Massachusetts Amherst Public Health and Infection Control Nurse. She has worked at University Health Services in this role since 2002.
